DESCRIPTION

Workwear bib pants fit perfectly thanks to ergonomically shaped COMFORT FIT cut. Sturdy twill tearproof fabric has a great mechanical characteristic and tensile resistance. Stretchy waistband with sew-in rubber band allows comfortable wearing; 2 front slit pockets, 2 back flap pockets, pockets for the snap-off knife, screwdriver, carpenter pencil; big slit flap pocket on the left leg; pocket for the folding rule, screwdriver and snap-off knife on the right side. The reflective piping in the knee area for better visibility, 2 segmented reflective stripes on the back and the front. Doubled fabric in the knee area, elastic braces, an inner slit pocket on the bib. Zipper ventilation with mesh netting.
