They feature a D-ring snap-hook, 2 hidden pockets, 1 front zip pocket, 1 front tool pocket with a wide loop, a multifunctional pocket for a folding tape measure, screwdriver and snap-off knife with wide loops on the right leg, and a large double pocket covered with a snap flap on the left leg.
